



Bike/Walk Central Florida Wheel of Achievement Award Application

Individuals, Organizations, or Agencies

Since 2010, BWCF has worked toward our mission of educating and advocating to make communities more walkable, bikeable, and rollable. The pursuit of our mission has afforded BWCF the opportunity to witness and participate in incredible public, institutional, and private efforts within the areas of policy, perception, and practice.

The 2023 Inaugural Bike/Walk Central Florida Wheel of Achievement Awards will recognize exemplary efforts that go beyond the minimum and truly move the needle in support of those who walk, bike, and/or roll throughout our communities.

Eligibility and General Information

Nominated projects/efforts or advocacy efforts must have taken place in Orange, Seminole, or Osceola County (or any combination thereof).

Ideal projects/effort or advocacy effort nominations have been fully or partially implemented within the last 5 years; for those projects not meeting this criteria, justification must be provided.

Applications must be received by 5:00pm EST March 31, 2023 through this online form.

Applications will be reviewed by the Bike/Walk Central Florida Awards Selection Committee (comprised of the BWCF Technical Advisory Committee and members of the BWCF Board of Directors). Awards for each category are ultimately at the discretion of the Selection Committee.

Awards will be presented at the 2023 Inaugural Bike/Walk Central Florida Wheel of Achievement awards banquet at the Center for Health & Wellbeing in Winter Park, Florida (June 15, 2023).

Award Categories

Bike/Walk Central Florida Special Achievement Award

For special achievements in support of making communities more walkable, bikeable, and rollable. This could include recent recipients of the League of American Bicyclists® Bicycle Friendly Business/Community/UniversitySM designation, charity efforts, publications and awareness campaigns, etc.

Outstanding Bicycle & Pedestrian Safety Project or Effort

For projects or efforts providing significant positive impact(s) to safety for all users of the bicycle and pedestrian network.

Small

For smaller projects or efforts (e.g., intersections; infrastructure less than 1-mile).

Large

For larger projects or efforts (e.g., community- or jurisdiction-wide; cross-jurisdictional; infrastructure greater than 1-mile).

Outstanding Bike/Ped Advocacy

Organization

For community- or jurisdiction-wide advocacy and education efforts created, facilitated, and implemented by a government agency, community organization, or private organization. Emphasis is placed on impact within the Bike/Walk Central Florida Key Priorities, below.

Champion

For advocacy and education efforts put forth by an individual community member or individual working within a government agency or private organization. Emphasis is placed on impact within the BWCF Key Priorities, below:

BWCF Key Priorities

Policy: Advocacy, education, and support of policies leading to reduction of serious and fatal bicycle and pedestrian collisions.

Perception: Normalizing walking, biking, and rolling and fostering a culture of courtesy amongst road users.

Practice: Encouraging people of all ages and abilities to walk, bike, and roll.

Sustainability: Long-term program sustainability to ensure lasting positive impacts for the community.
